

## Joyride car rental – Privacy Policy

---

Personal data collected through Joyriderental.gr from now on addressed as the “COMPANY”, are processed at national level. All personal data are dealt with in accordance with the applicable data protection legislation<sup>i</sup>.

- At EU level, the Regulation (EC) No 2018/1725 (1) on the protection of personal data by the Community institutions and bodies currently applies.
- At the national level, for members of the European Union (EU) and the European Economic Area (EEA), the General Data Protection Regulation ('GDPR') applies (2). All data processing operations under the control of the National Support Services comply with its provisions.
- For countries which are not members of the EU or of the EEA, personal data is processed according to the applicable National legislation, except if personal data from persons in the EU Member States or the EEA is processed. In this case, the GDPR applies.

The following Privacy Statement outlines the policies by which THE COMPANY collect, manage and use the personal data of the concerned individuals in Joyriderental.gr.

Who is responsible for processing your personal data (data controller)?

---

Which personal data are processed and how?

---

The COMPANY processes your personal data for sending the company information, materials, press releases, announcements, invitations, special promotions and newsletters.

a) Mandatory data

Registrant data: email address name, surname, telephone no.

b) Optional data (these data may be provided only in case you are further involved in Joyriderental.gr services): Tax number, Identity card no.

For which purpose do we process your data?

---

The processing of data is necessary to:

- provide information about the client and to establish and maintain online company's activities.
- allow clients to find our partners and confirm their reservation
- provide information about their car rentals
- in general, allow Joyriderental.gr clients to communicate and collaborate in the spirit of mutual trust and respect
- allow and facilitate monitoring and research of online reservations
- dissemination of national newsletters and notifications
- press releases
- promotion of events

Aggregated statistics are collected regularly, including the number of site users during a specific period, the preferred web pages or countries they are coming from.

Users may also choose to contact directly Joyride car rental to make a reservation. If users choose to contact the COMPANY directly, personal data will be solely used for the purposes of responding to messages or managing reservations.

On which legal basis do we process your personal data?

---

Processing is based on consent of the data subject (article 5(1)(d) of Regulation 2018/1725).

How long do we keep your personal data?

---

Data related to statistics reservation purposes is kept for the entire duration of Joyriderental.gr in an aggregated, anonymous format.

Who has access to your personal data and to whom is it disclosed?

---

For the purposes detailed above, access to the data is strictly limited to the COMPANY.

How do we protect your personal data?

---

The collected personal data and all related information are stored on secured servers of the COMPANY.

What are your rights concerning your personal data and how can you exercise them?

---

You have the right to:

Request to access the personal data we have on you

- Request a rectification of your personal data or make the correction yourself in your profile
- Request, Under certain conditions, the erasure of your personal data
- Request, Under certain conditions, the restriction of the processing of your personal data
- Object at any time to the processing of your personal data on grounds relating to your particular situation
- Request for your data to be transferred to another organization in commonly used machine-readable standard format (data portability)
- Withdraw your consent at any time.

You have the right to object to processing of your personal data on grounds relating to your particular situation under the provisions of Article 23 of the Regulation 2018/1725.

You also have the right not to be subject to automated decisions (made solely by machines) affecting you, as defined by law.
